



Schedule 8 Medicine Summary – VIC

Storage

Victorian regulations require S8 drugs to be stored in a locked facility, fixed to the floor or wall. The storage facility must provide the security of a 10mm (at least) thick mild steel drug cabinet and the S8 drugs must not be stored with any other items other than other drugs of dependence, which includes some Schedule 4 drugs (eg benzodiazepines).

For use in an emergency, up to SIX ampoules (in total) of S8 drugs may be stored in a locked facility that does not comply with the above standard.

When transported for use in another location, S8 drugs must be stored in a locked receptacle, such as a Doctor's bag, in the Doctor's possession. If the Doctor's bag is not in the Doctor's immediate possession, it must be secured in a lockable facility, such as a vehicle or cupboard, out of sight to prevent unauthorised access.

Records

Victorian regulations require a drug register to be kept for all transactions involving S8 drugs. A loose-leaf record book is not acceptable, the register must be a bound document. The drug register must have one drug including name, strength and form per page. Entries in the drug register must contain:

- *Date* of the transaction
- *Quantity* of the drug supplied/administered/obtained and the balance remaining.
- *Name and address* of person to *who drug is supplied/administered*.
- *Name and address* of the *person/company from whom the drug is obtained*.
- *Name* of person carrying out transaction.
- *Signature* of person carrying out transaction.

Example of Drug Register

The drug register must be kept for three years after the last entry is made.

Mistakes in the drug register are not to be deleted, but a correction added on the next line.

Destruction

- The destruction of S8 drugs must be carried out by a pharmacist, dentist, veterinary practitioner, nurse practitioner or medical practitioner and must be witnessed by a pharmacist, dentist, veterinary practitioner, medical practitioner or nurse.
- The details of the destruction, including the name, strength and quantity of the poisons or controlled substances destroyed, the method and place of destruction and the names of the persons carrying out the destruction and the witness are to be recorded in the drug register and made available for the inspection of an authorised officer when requested.
